VISION


We will build a stronger Jackson County by mobilizing our communities to improve people's lives.

Education

The Big Idea students went to SOU for a day! And what a day it was! SOU was absolutely amazing and each student had 13 different experiences from physics to theatre to Japanese to science and much more! U.S. Senator Jeff Merkley visited with the Big Ideas students and presented a flag that flew over the U.S. Capitol. In addition to large group experiences like these, more than 620 of the students received direct services such as sports physicals, eye glasses, clothes and more. Graduation rates are increasing and we're on the right path to 100% High School Completion for the Class of 2020.







Health

Jackson County CAN (Child Abuse Network) has changed its name and not its focus. Now called Rogue Valley CAP (Child Abuse Prevention), the partners presented a family fun night and the storytelling event in the park to raise awareness and to prevent child abuse in our community. CAP remains focused on prevention, public awareness and systems change to protect our Valley's children.

United Way is a partner in the Great Start, Eat Smart group and has helped to distribute thousands of DVDs with cooking and healthy snack demonstrations. If you're interested, give us a call!

FamilyWize Prescription Assistance has continued to save Jackson County folks money on needed medication. Since 2009, \$1,376,000 in savings has been provided!

Income

HOPE Chest continues to help people with emergency needs from rent and utility assistance to car repairs to keep jobs. Our VITA (Volunteer Income Tax Assistance) site hosted a visit from Congressman Greg Walden. VITA, in partnership with AARP TaxAide brings more than \$3 million back to Valley residents in earned tax credits.

Project Community Connect held its 7th annual event with 50 local agencies helping bringing vital services to people experiencing homelessness or near homelessness. With more than 100 volunteers, 770 people received services from haircuts, veterinary care for their animals, bus passes, bike repairs, and more.



Transportation

Our efforts to reduce barriers to transportation are rolling along (pun intended)! By bringing together partners to improve the transportation system, this work is making a difference. In addition to the policy work, our mobility manager provides group and individual travel trainings. Watch next year for Bike Share for the People of Jackson County! It launches in July 2015! Funded Partners

In addition to our impact work, we remain focused on our strategic investments in education, income, health and transportation funded programs. We provide critically needed resources to 48 programs serving 2 out of 3 Jackson County residents. These investments cover from prenatal care to be reavement counseling and much of life that falls in between.

All donations share in the cost of fundraising and administration along witha three-year rolling average of pledge loss. No membership dues or fees are charged to agencies receiving funding or members of the United Way of Jackson County federation of the Combined Federal Campaign.


