- Accounting and records retention policies regularly reviewed.

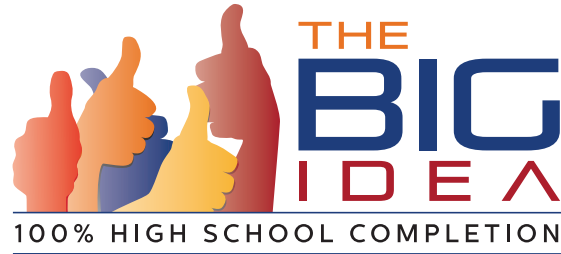

United Way is the proud recipient of a grant through Rogue Valley Transportation District and Oregon Department of Transportation for mobility management! Watch for exciting news in 2014!

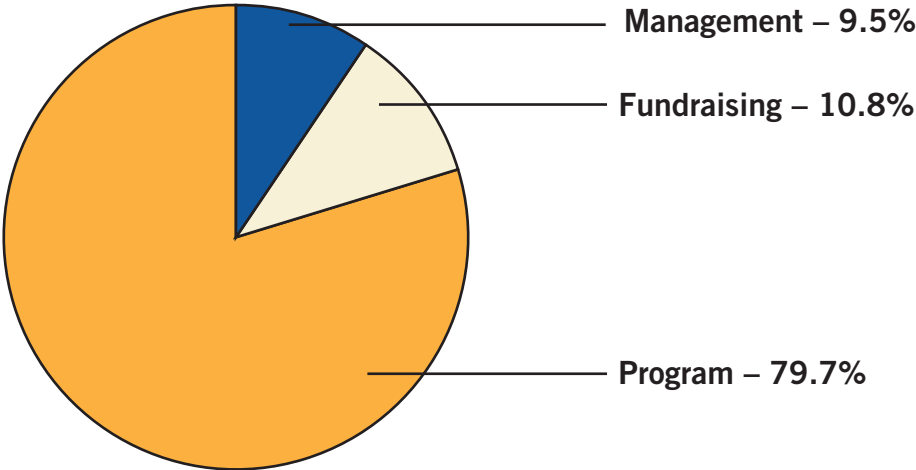
Funded Partners
